Savants does not make any express or implied promises, warranties, representations, or guarantees that use of the semen stored at our facility will result in conception or will remain the same, will be viable, or will be of any particular quality or motility over time. **Ownership/Shipping:** You remain in full ownership and control of the semen stored at Savants. Semen may be released for shipping by written request(form will be provided) and by paying fees associated with tank rental, tank prep, semen and document prep, and shipping fees. Savants is not responsible for any damage or loss in storage or shipping due to casualty such as weather, acts of God, fire or tank failure. Account must be up to date before any semen can be shipped. **Storage Fees:** The first year of storage is included in the price of your original collection. Yearly storage fees will apply each year thereafter. It is the responsibility of the semen owner to keep contact information updated with Savants. If invoices are returned undelivered they are considered unpaid. Unpaid invoices will result in late fees.
